Important Information:

This retainer corresponds to the first day of rent. By paying this retainer you ensure your reservation. Rent house owners use this retainer as a proof of your commitment to arrive on the date you specified. *Consider this document signed by the rent house owner, as a PAYMENT RECEIPT of your first day retainer.*

We receive this retainer and transfer it to the rent house owner. You will get acknowledge from the rent house owner that payment is received. When we deliver the retainer to the rent house owner, will get their signature as a payment receipt and will send you a scanned copy of this document (or a similar one) with that signature.

An additional fee (included in this invoice) is charged to cover funds transfer to rent house owners and reservation fulfillment documents.

After you arrive, you will need to pay the rest of the days of your stay. DO NOT pay the first day since it's already paid by clearing this invoice.

This retainer is NOT refundable if:

- you fail to arrive in the agreed date,
- you decide to use a different house,
- you cancel the reservation or you do not come for any reason.
- your reservation is cancelled by the rent house owner because you fail to adhere to early agreed terms such as arrival date or number of guests

This retainer is refundable if:

- you arrive at the agreed date but the rent house is full
- by any fault of the rent house owners they cannot accept your stay AND you arrive at the agreed date.

Since this retainer is transferred to rent house owners, if it should be refunded to you, the refund will be on-site in the rent house owner by the rent house owner himself. Transfer fees are not refundable.

Please note your reservation may be cancelled by the rent house owner if you do not adhere to the terms agreed when confirming your reservations, specially the arrival date and the number of guests. If you arrive late, or bring more guests, the rent house owner may cancel the reservation.
